Fully catered en-suite rooms

Single, twin and triple rooms are available all with en-suite accessible, shower rooms.

Apartments

Lyn – sleeps 4 - wheelchair accessible, one single bedroom with electric bed, one twin bedroom and pull down bed in the lounge. Accessible shower room.

Heddon – sleeps 7 - wheelchair accessible, split level with stair lift. Ground floor - one single bedroom with electric bed and pull down bed in the lounge, plus accessible bathroom with shower table. First floor – one single bedroom and one bedroom with four single beds, plus shower room.

Kinsford - sleeps 4 – stairs to apartment - not wheelchair accessible, one triple bedroom and one single bedroom, plus bathroom.

Bray – sleeps 4 – wheelchair accessible, one twin bedroom with electric bed, one single and a pull down in the lounge, plus accessible shower room.

Booking Terms and Conditions

To secure a reservation a non-refundable deposit of 25% must be paid over the phone with a credit/debit card, or within fourteen days of an invoice. Reservations made less than three months before the arrival date must be paid in full either over the phone with a credit/debit card or within fourteen days of an invoice. If you require longer to arrange your deposit payment please discuss this at the time of booking. Any remaining balance is then due twelve weeks before your arrival date.

Receipt of payment or a booking form confirms you have entered in a contract with CTE and you except our terms & conditions. We reserve the right to refuse bookings at our discretion.

The person making the booking is responsible for payment of the full amount due.

Cancellations:

Please notify us in writing if you have to alter or cancel your booking as soon as possible. We regret that no refund will be made for cancellations or reductions to the number of people in the booking if we are notified less than twelve weeks before your visit.

Cancellations will be charged on the following scale:

More than 84 days before visit	Deposit only
Less than 84 days before visit	Full payment

The above charges also apply to any reduction in the number of people in the booking.

If we have to cancel your stay for any reason you will be offered an equivalent visit at an alternative time or a full refund. As long as the Centre is open and operational we do not give refunds or amended dates if you are unable to travel due to adverse weather conditions.

We strongly advise that you arrange holiday insurance to include cancellation cover.

Additional Charges:

- Bed Linen: In the event of an accident, we are happy to supply an extra set of bed linen at £3 per set.
- Additional Cleaning: If a room requires excessive cleaning due to spillages, there will be an additional charge to cover the time and products necessary to make the room hygienic once again.
- Damage: If a carpet, piece of furniture or equipment cannot be saved, then the guest will be invoiced for the cost of replacement.
- Mid Visit Changeovers: A nominal charge of £3 is invoiced to cover the cost of fresh bed linen or £20 for a full bedroom clean.

Timings: We cannot accept arrivals before 4pm. Departure time is 10 am.

Activities: Activities are arranged in a fixed programme prior to arrival.

Groups of 9 or less – Please be aware if your group is less than 10 other visitors may join your group for activities.

Groups of 10 or more – If your group is for 10 or more people your group will be subject to the group tariff and no other visitors will join your group for activities.

It is the individual/group leader's responsibility to ensure our code of conduct is adhered to at all times.

Pets: Assistance dogs are welcome, but we regret that no other pets are allowed.

Restrictions:

We will always try to include everyone on all activities but occasionally this is not always possible. Assistance dogs are unable to attend horse riding, bike or water based activities, but can stay in the bedroom or our outside kennel. Non participating guests or visitors are unable to attend or spectate activity sessions.

Please be aware that we cannot usually offer horse riding or carriage driving at the weekends.

Sailing is only available on 7 night breaks taken between March and October.

The swimming pool is for our guests' to use as a leisure activity and may not always be available. The pool is not directly supervised by our staff and guests' are therefore responsible for their own safety. We require a minimum of three capable people in the pool at any one time, who are all able to raise the alarm in an emergency. Children must be accompanied by an adult. The Calvert Trust Exmoor cannot be held responsible for accidents in the pool.

Care Needs:

Guests should ensure that they come with adequate care support for a comfortable and enjoyable stay. We regret that we cannot provide care or supervision for our guests. We reserve the right to ask guests to leave without refund if they are endangering themselves, other visitors or staff as a result of their care or supervision needs. We recommend that guests in doubt consult with their doctor or other professional to discuss their needs before making a reservation.

Discounts:

These discounts do not apply to the group booking tariff.

Gastro fed - 10% off the fully catered tariff. Night waking staff – 10% of the fully/self catered tariff.

Children aged 3 - 5 can visit at 75% of the full tariff cost as they may not be able to take part in every activity.

Children aged 2 and under are free as they cannot participate in any activities.

Under 18's: A responsible adult must accompany individuals under 18.
